2. The fee must be received by May 29th with the application and a **self-addressed stamped envelope**. *Applications will not be accepted without payment. Any application received after deadline is \$100.00 per booth.*
3. No refunds made after May 29, 2009.
4. If you are selling food items at your booth (packaged only and not to be consumed at the marketplace), please contact the board of health at (260) 358-4831.
5. The booths are on the downtown streets. Bring your own tables, chairs, canopy, extension cord, etc.
6. Overnight Security will be provided on Friday and Saturday night.
7. No pets allowed. (strictly enforced)
8. The committee reserves the right to refuse any application. In such event, your fee will be returned.
9. Special requests will be considered but not guaranteed.
10. **SETUP**, 1- 3 pm Friday, 6-9 am Saturday, and 8-10 am Sunday (all vehicles must be out of Marketplace by 3 pm Friday, 9 am Saturday, and 9am Sunday).
11. Offsite parking will be available
12. It is **required** to be open 4 pm—10 pm Friday, 10 am - 7 pm Saturday and 11 am to 4 pm Sunday.
