Enjoy Huntington County's outdoor areas

Huntington County provides many areas for the community to enjoy the outdoors. Walking, hiking, biking and a variety of trails, reservoirs and parks offer opportunities to experience fresh air, trees, wildflowers, sports, waterways and exercise.

The system of trails continues to grow in Huntington County thanks to the efforts of HARTA (Huntington Area Recreational Trail Association). HARTA will hold its annual fundraiser in support of Huntington's trails on Friday, June 7 at the Huntington County Fairgrounds, 631 E. Taylor Street, from 6 to 10 p.m. The Huntington Trails Beer and Wine Festival can be attended by those 21 and over in the Beacon Credit Union Heritage Hall. For more information visit <https://harta-gotrails.org>.

Erie Trail, named for the significant contributions of the Erie Railroad to Huntington, begins at Hier's Park and travels north across the historic Erie Railroad bridge, continuing through Yeoman Park. It then follows the Erie trail bed north to Gragg Street making easy access to several city parks, Parkview Huntington Hospital, Parkview Huntington YMCA, Crestview Middle School and Huntington University.

Etna Trail Section travels along Etna Avenue beginning at Jessup Street and ending at Waterworks Road where the city limits end. Evergreen Trail is a one mile paved loop walking trail at Evergreen Park on Evergreen Road. Along this trail decks can be found that overlook the Wabash River, and a wildlife prairie is home to seven different flowers and grasses.

The Lime City Trail walks along the banks of the Wabash River and begins on West Park Drive across from Huntington Nursery. The paved section has a view of the Nuck House, Schoolhouse and the former home of Chief Richardville in the Historic Forks of the Wabash Park. The trail continues on into the woods complete with wood walkways and a bridge. When completed it will continue on to the PAL grounds, totaling over five miles.

The City of Huntington can be toured on



the five bike routes that start and end at Schenkel Station in downtown Huntington. Each of the five bike routes offer different distances and sights of the city.

The Pehkokia Woods Acres Land Trust preserve begins at the parking area at 1570 Flaxmill Road. The area has a 1.9 mile hiking trail and is named for the Miami word "peace." The surrounding woods feature a variety of trees and a small pond. The upland forest is dissected by a number of 20-foot-deep ravines.

The Tel-Hy Acres Land Trust area is located at 1429 N 300 W. It provides 1.1 miles of hiking trails on 39 acres of land. Tel means "high" in Hebrew and Hy means "life." Visitors can view a variety of trees, wildflowers and the Wabash River from a high bluff above.

Two area reservoirs also provide opportunities to enjoy the outdoors. J.E. (J. Edward) Roush Lake Fish and Wildlife area includes 7,347 acres of land, 900 acres of lake and is approximately 15 miles long. Recreational areas include Kil-So-Quah Trail and Lookout Mound, hiking and biking trails, a campground, boat ramp, a shooting range, areas for wildlife watching and birding, hunting areas and more.

Salamonie Lake is filled with scenic trails on the 12,554 land acres. It also includes 2,665-acres of lake property with 40 ponds,

marshes and wetlands. The Lost Bridge West State Recreation Area (SRA) provides learning opportunities, a modern campground, a horseman's campground and more. The Salamonie Lake property also includes a swimming beach, basketball and volleyball courts, hiking and biking trails, boat launch ramps, a marina, bridle trails, (Story Continued on Page 2)

canoeing/kayaking, cross-country skiing, fishing/ice fishing, picnicking, shelter house, playgrounds, snowmobile trails and more. Huntington has a large selection of parks to visit and enjoy.

Hier's Park is located at 547 S. Briant Street; Elmwood, along William Street; Evergreen, which includes an Arboretum, 1370 Evergreen Road; General Slack, Guilford Street; Laurie, 503 Grayston Avenue; Memorial Park and Sunken Gardens, West Park Drive; Memorial Hills Disc Golf Course; Terry R. Abbett Splash Park, 1215 Etna Avenue; Rotary Centennial Park, 551 N. Jefferson Street; Veterans Memorial; Yeoman Park, Second Street, includes Hayes-Lemmerz Skate Park, BMX Track and Barks and Recreation Dog Park.

In celebration of Arbor Day a special event will be held at Evergreen Park on Saturday, April 27. Volunteer efforts will take place from 8:30 to 1 p.m. with the public event from 10 a.m. to 1 p.m. The day will include tree mulching and planting, local artists' rain barrel silent auction, nature ac-



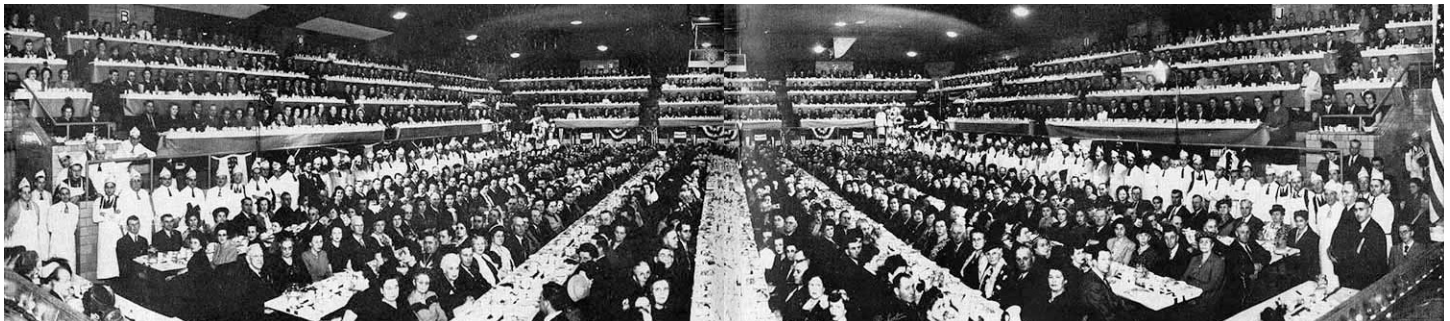
The Erie Railroad bridge can be found on the Erie Trail, crossing the river between State Street and Riverside Drive.

tivities and crafts for all ages, live music and an official Arbor Day proclamation by Mayor Richard Strick.

The Huntington Parks and Recreation Department maintains the local parks, and provides a lighted Christmas display in Sunken Gardens and the adjoining Shakespeare Gardens. It also programs and lights the Christmas tree in Rotary Centennial

Park. Visit Parks and Recreation at huntington.in.us.

Two additional parks in Huntington County include Drake Goetz Memorial Park located along Union Center Road near Union Church, 4082 N 350 E, a not-for-profit community park with inclusive playground equipment, and Lake Clare Fitness Park, 1005 Broadway.

Chamber promotes betterment of Huntington County

The members of the Huntington Chamber of Commerce were always looking to find ways "to promote any movement which had for its purpose the betterment of Huntington." With this in mind in the 1930s and 1940s, the Chamber became involved in the care of its citizens and was located in the former Hotel LaFontaine.

Following World War II, in the 1930s and 1940s, the Huntington Chamber of Commerce sought ways to help veterans of the war acclimate into the Huntington community. It became the administrative office for veterans housing as part of this effort. Today the Veterans Service Office, 1350

South Jefferson Street, assists veterans, their widows, spouses and dependents in receiving benefits.

Chamber members also found ways to raise funds for those in need. These efforts led to the beginnings of the Community Chest in 1947, which was a forerunner of today's United Way. The Chamber raised \$28,000 for a \$23,000 quota in this early campaign.

The Farmer's Achievement Fish Fry also began during this time. The event, sponsored by the Chamber, brought 1,600 businessmen and farmers together and helped to support the beginnings of 4-H.

Brock Zehr, outgoing Chamber board chairman, then introduced incoming Chamber board chairman, Todd Latta. Latta thanked Zehr for his years of service to the Chamber and presented him with his outgoing chairman plaque.

State Senator Andy Zay surprised everyone by approaching the podium and congratulated the Chamber. He presented a framed proclamation from the Indiana General Assembly and the State of Indiana detailing the Chamber's importance, and for serving Huntington County over the past 100 years.

The Sweetwater All Stars then entertained the crowd with an evening of R&B music. Talented musicians and singers presented an hour of spirited selections for the enjoyment of all.

Century, Half Century awards now accepted

Nominations are being accepted for the Governor's Century and Half Century Business Awards, which honor Indiana businesses that have remained in operation for at least 100 or 50 years, respectively.

The businesses must also have demonstrated a commitment to serving the community, a news release from the Indiana Economic Development Corporation said.

The state has several other qualifying criteria for the awards.

- * Have had continuous operations in Indiana for 100 or 50 years by December 31, 2023.

- * Have participated in the same line of work for the duration of its operations. If different, an explanation of the evolution into the current business must be provided on the nomination form.

- * Have had its base in Indiana since it was founded.
- * Recognize, acknowledge and agree that it is in full compliance with the Indiana Secretary of State.

- * Not have previously received a Century or Half Century award from the state of Indiana. Previous Half Century award recipients may qualify for a Century award.

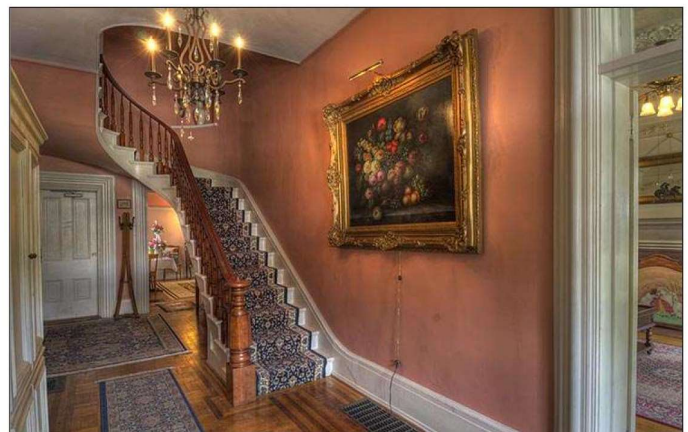

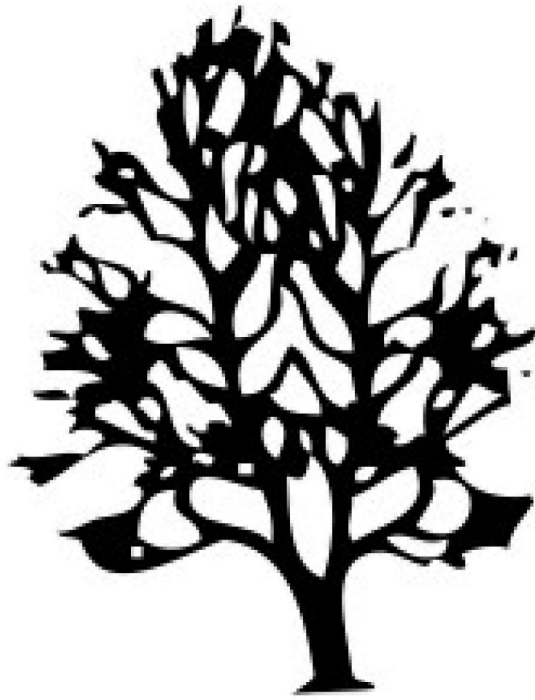
