Happy 175th Birthday City of Huntington!

The City of Huntington is celebrating its 175th anniversary in 2023. Mayor Richard Strick, city officials and employees began the “demisemiseptcentennial” celebration with a proclamation on Tuesday, January 3, at the Huntington Fire Department’s Etna Avenue station.

Huntington’s incorporation as a town was made official on February 16, 1848, and its reincorporation as a city took place 25 years later on September 17, 1873. The proclamation read on January 3 recognizes the families and neighbors who work together to make Huntington a great place to call home, as well as the community organizations and local business community that help Huntington flourish and thrive.

A demisemiseptcentennial committee has been working behind the scenes to organize community events that will recognize the anniversary and celebrate all things Huntington. Many of the events for Huntington’s 175th are still in the planning stages – watch for more information to come!

The next event up is the first in a series of monthly Scavenger Hunt Adventures sponsored by the Huntington City-Township Public Library and Huntington County Visitor & Convention Bureau. All ages are welcome.

Each month from February to August, a different Huntington-related scavenger hunt will lead participants around the city to explore Huntington in a new way. Answers to scavenger hunt clues will be found both around town and online. It’s a great chance to see the brand new city/county website while you’re at it! Scavenger Hunt Adventure topics will include themes such as city services, local parks, historic architecture, famous names and more.

Those wanting to take part can find the scavenger hunt clue sheets at the library, 255 W. Park Drive or Huntington County Visitor Bureau office, 407 N. Jefferson Street. Completed sheets can be turned into these venues and will be entered into a monthly prize drawing. All entries also will



be entered into a September grand prize drawing for an “Ultimate Huntington Basket.”

A variety of local businesses will be offering special discounts and unique items for sale on a monthly basis. Bear & Beak Bakery will sell “Huntington-isms” cookies in March.

The Huntington County Historical Museum, 315 Court Street, created a new video late last year telling the story of the founding of Huntington and Huntington County. Plan a visit to the museum to learn even more about Huntington and its development through the years.

The City is also working with Huntington North High School’s Student Council to plan fun and memorable activities for students. These events will be announced soon.

“Huntington at 175 Years” is the theme for this year’s Heritage Days, which will be celebrated June 14 through June 18. A variety of events are being coordinated by a

steering committee of the Huntington County Chamber of Commerce. Participants in the annual Heritage Days Parade on Saturday, June 17, are encouraged to carry out the theme on floats, motor vehicles and other entries.

A Quayle Center celebration is planned for the month of August. It has been 30 years since the Quayle Center’s inception and speakers are being arranged for this anniversary event.

Constitution Day will be celebrated September 16 and 17. An impersonator of Huntington’s namesake, Samuel Huntington, will lead a program centered on Huntington’s 175-year celebration.

The Huntington County Chamber of Commerce will “Celebrate Huntington” at its annual dinner on Tuesday, March 14. Those in attendance will celebrate business, education, sports, community life and Chamber contributions throughout the evening.

A New Year’s Eve Gala on December 30 will wind up the 175th anniversary festivities. The formal gathering is in the planning stages by the City of Huntington’s demisemiseptcentennial committee.

There are more activities still in the works, with more details to be revealed. We are excited to celebrate all things Huntington as a community in commemoration of our city’s 175th birthday.

Silver Moon 3 Pub grand opening, ribbon cutting is February 11

The organizers behind the restoration of the historic Milligan Block on Huntington's N. Jefferson Street have a lot to celebrate. The Victorian-era building dating back to 1883 has officially reopened as Silver Moon 3 Pub, a café style gathering spot with a menu of seasonal, light fare and cocktails, mocktails or other choice beverages.

The public is invited to a ribbon cutting celebration starting at 5 p.m. February 11 at Silver Moon 3 Pub, located at 32 N. Jefferson Street. The pub offers a full menu of fresh, seasonal shareables, salads, hot sandwiches, soups and desserts, as well as specialty cocktails and mocktails.

Ian Stallings, an investor with family ties to the historic building, said the grand opening celebration will include extended hours and a surprise entertainment guest.

"This is a big celebration — a place where people can chill and hang out with good vibes," Stallings said, adding, "We're going to stay open late and have some fun."

Silver Moon 3 Pub is operated by Ian Hasselbacher who has experience in bar and nightclub management. Joining him is his mother, Charisse Opie, head of the kitchen.

Hasselbacher created an approachable and elevated cocktail and mocktail menu using fresh, delicious ingredients while Opie created a fresh, seasonal café menu with light dishes.

"It's important to note that our drinks menu has options for people who don't want to drink alcohol. We use ingredients that taste great with liquor or without," Hasselbacher said.

Hasselbacher and Opie moved from California and call themselves, "new, proud Hoosiers."

"We have been very humbled by and grateful for the support we received," Hasselbacher said. "We're excited to bring back a beloved space that is filled with many fond memories for people in the region. This is a neat opportunity."

Silver Moon 3 Pub is a place where patrons can have a quick meal and a drink on the go, but it is also a place to come together in a meaningful way. The real goal is for it to be a place to gather and hang out. Stallings said the pub-style café is designed with limited family-style seating and a focus on the bar as a "huge communal

table," to encourage guests to talk to each other and make new memories.

"We want you to hang out for a while — have meetings for lunch, have your after-work cocktail or coffee, have drinks with friends," Stallings said. "Come meet a friend. Come meet your neighbors and help us host visitors to Huntington, so they can see how wonderful this city is."

Milligan Block was one of a handful of historic Indiana buildings to be awarded a grant from the OCRA (Indiana Office of Community & Rural Affairs) Historic Renovation Grant Program that is designed to preserve and rehabilitate historic properties to further incentivize downtown economic development across Indiana. The Milligan project received \$100,000 in grant money, a distinction shared with the Kurt Vonnegut Museum and Library in Indianapolis.

Silver Moon 3 Pub is located at 32 N. Jefferson Street in Huntington and open from 11 a.m. to 11 p.m. Wednesday-Thursday, 11 a.m. to 12 a.m. Friday-Saturday, noon to 8 p.m. on Sunday (featuring a special Sunday Night Roast on Sunday 5 to 8 p.m.) and closed Mondays and Tuesdays. Economic Outlook rescheduled for February 16

The Economic Outlook that was scheduled for Thursday, January 26 has been rescheduled for Thursday, February 16. The event will be held at the Historic Forks of the Wabash at 8 a.m. The Forks is located at 3011 W. Park Drive.



When O'Donnell spoke in January of 2022, he was concerned about inflation, anti-growth policies, a war on energy production not associated with wind and solar and a more general undermining of traditional values and liberties. The undermining he spoke of works against education, work ethic, the profit motive and merit. Each of which has for generations been at the heart of America's economic success as a nation and world leader.

As the calendar is turned on a new year, 2023 does not, according to O'Donnell, look a whole lot different from the way 2022 looked when it began. As O'Donnell sees it, inflation may have peaked, but it's not going to go away without more pain. Maybe a lot more. The stagflation we experienced in 2022 will very likely give way to a full blown recession in 2023, as the labor component of inflation is fought by the Fed with higher rates for longer.

O'Donnell says the Fed is doing the heavy lifting here. He believes it never has raised rates so quickly while, at the same time, shrinking its balance sheet. He feels the policy makers of our federal government continue to be as anti-growth and anti-business as ever. They see environmental, social, racial and sexual issues as the battles they wish to fight, not the condition of the American economy. By the end of January, the unfolding economic and investment mess we are facing will likely be clearer. O'Donnell will tell it as he sees it. Come and hear him. It promises to be an interesting morning.
