Entrepreneurial 'Meet and Greet' in Warren

The Exchange, 201 N. Wayne Street, Warren, was the location of the Huntington County Chamber of Commerce's third entrepreneurial gathering 'Meet & Greet.' The event was held in partnership with Historic Warren Main Street on February 26 with over 40 entrepreneurs and prospective entrepreneurs attending.

Steve Kimmel, executive director of the Chamber, began the evening by welcoming those in attendance and explaining the Entrepreneurial Leadership Council under the direction of the Chamber. Jeff Souder of Historic Warren Main Street also welcomed those in attendance to The Exchange building, which was donated to Warren by the former PNC Bank. He explained the building was constructed in 1887, and he and wife Becky have been instrumental in its restoration. He thanked the town of Warren, the Huntington County Commissioners, Huntington County Chamber of Commerce and the Huntington County Community Foundation for their support of the project.

Kimmel said "The goal of the Council is to grow entrepreneurial wealth, and encourage more entrepreneurs to open businesses or to attract more businesses to open in our county." He continued, "New businesses help to bring growth and development to the community with the support of residents and existing businesses; in other words, we grow the community."

Kimmel then introduced John Niederman, director of the Fortitude Fund through Elevate Northeast Indiana. Niederman explained the Fortitude Fund and its support of entrepreneurs, "We have helped 270 entrepreneurs with \$1,000 grants, and we like to connect people. There are entrepreneurs we have helped in the room tonight." To learn more or apply visit fortitudefund.com.

The Wagon Wheel and Son-Rise Bakery, both Warren area businesses, provided the food for the evening. Created Décor, a Warren retail store located at 123 N. Wayne Street, provided the handmade centerpieces for the tables. Created Décor features home décor, gifts and handcrafted items, and is

The entrepreneurial 'Meet & Greet' featured two entrepreneurs who spoke about their businesses. Brady Smekens, co-owner of Smekens Education Solutions, Inc. along with wife Kristina, thanked the Chamber for coming to Warren, and gave kudos to Becky and Jeff Souder for transforming the space used for the evening.

Smekens explained that Smekens Education Solutions provides services to public and private schools. He said, "Teachers need to learn updated strategies to connect with kids to produce stronger readers and writers. Schools hire their company and they share strategies to help teachers implement what they learn."

He continued, "We have over fifty books and professional tools to help teachers do a better job. We have six consultants hired to go into elementary schools to implement our strategies."

oment for teachers. During that time, they have worked with hundreds of schools and thousands of teachers to equip educators with their practical innovative literacy strategies."

Smekens Education Solutions is located in the former Eckman building at 123 E. First Street in Warren. Brady and Kristina were both involved in education as teachers and in administration when beginning the business. He explained that the business began as a corner desk in the Smekens home, moved to their garage and eventually to the Eckman building. He is grateful for the local partners who helped the business, "We feel blessed to have had the opportunity to be in the right place with the right people."

Krysta learned that the owners wanted to sell the business.

Krysta said that she loved to bake and was interested in beginning a bakery, met the owners, helped them out for a few months to see if she wanted to start a bakery and eventually bought the business. She explained that she made many changes, used

her own recipes and made a business plan. She then moved the business and created a café style atmosphere. She wanted the bakery to be a place "where you could meet with friends or use a laptop."

Son-Rise Bakery has a complete line of breakfast items and serves hot breakfast items all day. A lite lunch is offered such as ham/cheese Paninis, grilled cheese and chicken salad croissants. Sunken Gardens, one of Chamber's efforts

One of the first efforts of the original Huntington Chamber of Commerce included Sunken Gardens. Formerly an old stone quarry which had been regarded as an eyesore, the area was transformed into Sunken Gardens.

Sunken Gardens, located at West Park Drive and Dimond Street, is part of Memorial Park. Sometime between 1914 and 1920 the Keefer and Bailey Lime, Brick, Tile and Cement Company abandoned this quarry in Huntington. The quarry became quite an eyesore until 1923 when the proposal was made to convert it into a sunken garden.

The City of Huntington acquired the Cold Spring Woods, surrounding the quarry area, and began the beautification of the woods, transforming the area into a park. It was dedicated in 1920 to Huntington's war dead, naming it Memorial Park. A group of members of the Chamber of Commerce, headed by E.M. Wasmuth, acquired the old stone quarry, worked toward its appeal as a sunken garden and transferred it to the city in 1924.

The Chicago Landscape Company created a plan for the site that transformed it into a naturalistic and informal setting. Fieldstone staircases were constructed leading down the steep banks into the quarry, and lagoons were located at the bottom. Plantings, footbridges and picturesque walk ways were scattered through the gardens. The 1.5-acre multi-level site included limestone walls, three different entrances and an automobile-related fieldstone bridge. In November of 1929 Sunken Gardens was featured in *Better Homes and Gardens* magazine.

Time and the lack of money caused Sunken Gardens to lose their luster until the City of Huntington supported a revitalization project from 1964 to 1967. Currently Sunken Gardens and surrounding Shakespeare Gardens feature a Christmas light display during the winter season that attracts thousands to this multi-level area. In 2010 a grant provided funds for the restoration of the historic stonework, and Sunken Gardens continues to be a respected landmark of restored beauty and community pride. Sunken Gardens/Shakespeare Gardens are cared for by the Huntington Parks and Recreation Department.

Hoosier exhibit at museum is March 4 to April 2

The many creations of Hoosier cartoonists are being highlighted with the Indiana Historical Society's (IHS's) traveling exhibit, *From Pencils to Pixels: Hoosier Cartoons and Comics*. From March 4 to April 2, the Huntington County Historical Society will host the exhibit at the museum, located at 315 Court Street, Huntington.

From Pencils to Pixels explores the adventures of comic strip characters such as fat-cat Garfield, Brown County savant Abe Martin, and "Chic" Jackson's "Roger Bean," which featured the lives of a typical Hoosier family.

Drawn from the collections of IHS, the Indiana State Library and other institutions throughout the state, the exhibit also examines the life and work of the Indiana artists who have entertained and informed millions of newspaper readers (with syndication) across the country.

Visitors will learn about "ean of America's editorial cartoonists," Evansville's Karl Kae Knecht; "the first black political cartoonist," Henry Jackson Lewis, who worked for the *Indianapolis Freeman*; Richmond's Gaar Williams, who earned a designation as the "James Whitcomb Riley of the pencil," and Muncie's Jim Davis, responsible for bringing Garfield to life.




